Two Ventura County Sheriff's Deputies Charged for Off-Duty Bar Assault

VENTURA, Calif. – Ventura County District Attorney Erik Nasarenko announced today that charges have been filed against two Ventura County Sheriff's Office deputies for their roles in a March 30, 2025, off-duty assault at a Camarillo bar. Dylan Davis (DOB 02/12/91), of Ventura, and Anthony Malagon (08/19/97), of Camarillo, are each charged with felony assault by means likely to cause great bodily injury. Davis also faces a separate felony charge of spousal battery and a separate misdemeanor charge of battery.

The charges stem from an altercation that occurred shortly after midnight on March 30, 2025, outside the El Rey Cantina in Camarillo. Davis and his wife are alleged to have argued inside the bar, and their argument continued outside, where the argument escalated into a physical confrontation. Davis and Malagon are accused of jointly assaulting a security guard who intervened after he witnessed Davis allegedly assault his wife. Davis is also accused of battering a female off-duty deputy who tried to restrain him during the altercation. The security guard was transported to a local hospital following the incident, where he received treatment for his injuries and was later released.

The Ventura County Sheriff's Office Major Crimes Unit immediately launched a comprehensive investigation of the incident, which led to the filing of criminal charges.

"The felony domestic violence and assault charges are particularly serious and reflect the outcome of a comprehensive investigation by the sheriff department's major crimes division," said District Attorney Nasarenko. "No one is above the law, and our office will continue to work with our law enforcement partners to bring justice to all crime victims."

Senior Deputy District Attorney Tony Wold, a member of the Ventura County District Attorney's Office Public Integrity Unit, is prosecuting the case. Davis and Malagon had their arraignments continued to August 7, 2025, at 9:00 a.m. in courtroom 37 of the Ventura County Superior Court.
